## Why Does The Conference Meet?



The 2021 WSC to approve the creation of a new Electronic Meetings AREA at the 2022 WSC, with an elected Delegate to the WSC!



## How could PEMs Becoming AFGs affect the CO Area?

- WSO suggests that each Area internally discuss and decide, if they want to accept into their Area, the new location-less Electronic AFGs that ask to join their Area.
  - WSO has a suggested Guidance on how an Area might decide this.
  - There are many considerations.
- This can not happen until after the Electronic Area is created.
- The soonest time would be after the new proposed area has completed their work and the 2022 WSC approves its creation.

- It is not known if any of the new Electronic Groups in the new Electronic Area will be interested in asking the CO Area if they could join it.
- WSO has said that no decisions are immediately necessary for Areas to make.
- If a new Electronic Group wants to move into the CO Area and the CO Area does not have policies/procedures in place, the Electronic Group will need to wait until the CO Area is ready.
- CO Area needs to decide what to do and when to start!

## New 2021 Al-Anon Members Survey

- Your participation is needed to provide data-supported information to mental health professionals so that they might consider referring their clients to Al-Anon for support!
- New Longitudinal Study does that!
  - This approach allow WSO to determine the long-term effectiveness of Al-Anon to help the Friends and Family members of the Alcoholic to get healthier!
  - Developed by researchers
  - Survey asks if you want to opt-in
  - Participates will be re-contacted, by email, once a year for next 4 years, until 2026.

## Conference Approved Al-Anon Literature

#### **Updated Alateen Preamble:**

Alateen, part of Al-Anon Family Groups, is for young people who have been affected by alcoholism in a family member or friend. We help each other by sharing our experience, strength, and hope.

We believe alcoholism is a family disease affecting everyone emotionally and sometimes physically. Although we cannot change or control the alcoholics in our lives, we can detach from their problems while continuing to love them.

In Alateen we focus on our own program rather than outside issues such as religion, politics, social media, or other Twelve Step programs. There are no dues for membership. Alateen is self-supporting through its own voluntary contributions. Alateen has one purpose: to help young people affected by someone else's drinking. We are careful to protect each other's anonymity as well that of all Al-Anon and A.A. members.

By applying the Twelve Steps to ourselves, we begin to recover from the effects of the family disease of alcoholism mentally, emotionally, and spiritually. This allows us to encourage our alcoholic relatives and friends, and to give hope to other teens.

However, total revenue was lower that in 2019 and expenses were cut on Program and Administrative Services




















## 2020 WSO Annual Report- Literature-What is the status of the New Daily Reader

- Status of our New Daily Reader (working title)
  - In 2020, a total 1,887-member sharings were evaluated by the Associate Director of Literature and the 14 Literature Committee members. After intense work, a first draft was created and evaluated, and hundreds of opinions sent back to the writer/editor to create a near final draft.
  - In the first half of 2021, the near draft was sent to the Literature Committee for the beginning of its CAL approval.
  - Once the book undergoes the rest of the CAL process, it will be introduced in July 2023 at the Al-Anon International Convention.
  - The goal is to provide a helpful source of recovery to all Al-Anon members for years to come!






World Service Office Organization Chart - March 01, 2021
