Information for Al-Anon Members in Alateen Service (AMIAS)

Steps to become a new AMIAS in 2023

- **Read Colorado Area Alateen Safety Guidelines for minimum requirements**
- **Apply anonymously to American Screening for background clearance**
- **American Screening will notify you of clearance**
- **Complete AMIAS training (contact Alateen Coordinator)**
- **Submit 2-page application paperwork to Area Alateen Process Person (AAPP)**
- **Members can apply for new certification at any time. *No Deadlines*!**

Information for Al-Anon Members in Alateen Service (AMIAS)

Existing AMIAS Requirements

- All existing AMIAS must attend training to re-certify in 2023.
- All AMIAS must re-certify every year between January and March.
- Recertification forms must be to AAPP by **** March 31st, 2023****
- Recertification for existing AMIAS: same 2 application forms used for new AMIAS applications.

- **Submit **annual update** using Alateen Group Change Form to AAPP, noting changes (or none). Please submit by March 31st.**
- **Submit Group Change Form at any time to AAPP if changes in location, access, meeting times, inactivation, or special notes.**
