- 1. What do you see as the advantages of continuing to hold Assemblies in conjunction with A.A.?
 - AA hosts and Al-Anon has it's own thing.
 - AA gets a good venue rate.
 - We are kind of an offshoot of AA
 - Bigger Fellowship opportunity.
 - Sharing resources and hearing both Al-Anon and AA speakers add to the depth of the experience.
 - Less Costs for attendees therefore group expenses.
 - Hearing both AA and Al-Anon member stories.
 - Diversity, compassion, and more understanding.
 - I like it feels like we are cooperating with them.
 - But I don't interact with them other than the speaker in the evening.
 - Seems like the pricing is better with a larger group.
 - History of it all.
 - Cost is probably less. Greater #'s = greater discounts.
 - Coordination of food.
 - Financial, fellowship.
 - Facilitate a spirit of fellowship and collaboration for the two sides of the coin.
 - Increase #'s of participants may arrow pointing down [lower] costs per participant (e.g. group rates for rooms).
 - Family members (e.g. husband & wife) in both programs can attend together.
 - Fellowship with AA.
 - Probably most economically viable from an individual perspective.

- Tradition 6 cooperation with AA this is one of the major ways that we do cooperate.
- Tradition 5 by doing this together we are encouraging and understanding the alcoholics.
- Members who are dual members can easily participate in both assemblies (even though by nature no one would be voting in both).
- Families who have members in both programs could attend together.

- 2. What do you see as the disadvantages of continuing to hold Assemblies in conjunction with A.A.?
 - AA determines where/when.
 - Al-Anon becomes too reliant on AA support and does not build an independent and strong base of our own.
 - May/may not be as beneficial.
 - Confusing where to sign in and who you're sitting next to in the hospitality room, sometimes uncomfortable.
 - Too large and hard to get rooms in the hotel.
 - Maybe more venue choices if we were alone.
 - Don't know what cost for Al-Anon would be if not in conjunction with AA.
 - Tradition 4 Each group should be autonomous except in matters affecting another group or Al-Anon or AA as a whole. At present, Al-Anon is not doing its share financially in supporting AA cost and expense for hosting. Maybe Tradition 7 also.
 - Al-Anon always feels like a 2nd fiddle, more taco bars and ice cream socials.
 - Are we self supporting?
 - Congestion.
 - Maybe limited fellowship interaction due to agendas.
 - History but no documentation.
 - Can't think of any.
 - More costly to Al-Anon, smaller venues, loss of diversity in speakers/meeting/fellowship, less services available in the Assembly.
 - Will cost us more.
 - More work involved.
 - Not seeing and talking to AA friends.
 - Communication issues.
 - GR speaking, I haven't been to many but as an Al-Anon it was tough to get a handle on all the info and details.
 - If we are new, we were not in the loops of knowledge.
 - It felt awkward and embarrassing.
 - My DR had to do a ton of work for me! The website update might help us.
 - Can't think of any, unless we feel dependent on them.
 - No say over where the assemblies occur or if AA changes duration/format.
 - They dictate where the assemblies are held and not always the best place/time. Like Cripple Creek a weekend before Thanksgiving in a potential snowed in place.

- I feel we obligated to go from Friday to Sunday, and not sure if we really need to do that.
- Al-Anon has no voice/choice in selection of location.
- Increased nightly costs associated with large hotel spaces.
- Going wherever AA decides to hosts, not always excited about it.
- I see no disadvantage.
- Accommodations I wasn't able to book a room at this hotel so I could only attend for the day today, and I was not able to park at the hotel I almost thought I was going to have to turn around and go home.
- Harder to find venues.
- Parking gets full.
- You can hear them having more fun than us.
- I don't see disadvantages in continuing to hold joint assemblies.
- Al-Anon has to go where AA goes and has minimal to no input.
- Limits Al-Anon's options regarding length of assembly because contract with venues would be very complicated if Al-Anon was, for example to meet, only Saturday. This also applies to how frequently we meet.
- It is impossible fright now to confirm that Al-Anon is being self supporting. This may cause Al-Anons to stay away.
- None.
- No control over venue, dates, areas we meet.
- We don't have a say in the city, hotel, etc ...
- We don't mix at the assembly except for lunch and a speaker.
- AA would likely ask us to pay more to offset their cost.
- Too expensive. Many Al-Anons sit out.
- I would not be in favor of paying more (fully self supporting) unless we get to have more say in the city/district and venue.
- Al-Anon are limited choice when and where for assemblies if we are beholding to AA to when and where AA chooses.
- We have less ability to determine best location and date.
- More or less expense?
- Too many people in hospitality room.
- Are we self supporting?
- No control over where we meet.
- Becomes complicated if we move to occasional assemblies completely online.
- Too big! Too expensive.
- The more people the more problems of having enough rooms available and cost of venue.
- Longer time for assembly 2 days vs. maybe 1 day with just Al-Anon.
- Very large meeting. My co-traveler and I had to get a room in a different hotel.
- Size, control.

- As the amount of attendance of members can increase where it limits where to hold assemblies.
- Zero.
- We are yanked around the state based on their demographic and convenience rather than choosing a location more convenient to our body.

- Will online participation result in significant impact on revenue from coffee, lunch and ice cream?
- Not sure, maybe cost.
- Venues crowded, rooms sell out, less say in location.
- AA calls the shots.
- We have not had an assembly in Colorado Springs in years.
- We do need hard numbers. Why is it a gray area how much hotel rooms etc.?
- AA approached us hope we can all work together.
- Better deals for Al-Anon at hotels etc.
- We pay AA \$700.00 per assembly.
- Size of venues. to host both assemblies , as well locations.
- Other than same cost and effort, there are no direct correlation between the two assemblies.
- Are we being fully self supporting?
- Cost of large enough venue for joint assembly.
- Smaller voice in desition process for venue, dates, number of assembly.
- Junior partner appearance to AA.
- Lack of Al-Anon flexibility, 3 assemblies don't "have to" be the same 3 day format.

- What do you see as the advantages of Al-Anon holding Assemblies independently?
 - Being fully self-supporting.
 - Allows Al-Anon to grow independent of AA and keeps the focus on ourselves.
 - Al-Anon can more easily make changes beneficial to Al-Anon.
 - All Al-Anon protocols in place.
 - Feel safer without fear of being around former alcoholics (if they ever were/are sober).
 - Maybe smaller districts could host.
 - We would need to be self supporting which is our Traditions.
 - It would be purely Al-Anon in choosing when and where ...
 - Would be great to have 100% Al-Anon.
 - Fully self supporting.
 - Less congested.
 - Greater choice of venues since smaller number of participants.
 - ? Lower cost if smaller venue.
 - Control of date/venue/content (most likely at greater cost).
 - Autonomy in venue selection, speakers, food, etc.
 - Strengthens Al-Anon fellowship.
 - May give some Al-Anon members a less intimidating experience.
 - We would be self-supporting.
 - Could choose our dates.
 - Possibly more anonymity and comfort. I find my comfort level increases
 when I am in a space without alcoholics, even when I love many of them. I
 have experienced years of trauma, so I put up my guard around perceived
 gruffness, loud, smoking, familiar men who were abusive. "The body Keeps
 the Score", a book on trauma.
 - We can hold meetings in smaller venues, maybe in the mountains. We could have more choices.
 - We could find out what it would cost to be fully self-supporting.
 - Closer adherence to the financial tradition/principles to be self-supporting.
 - We pick time and place. It may not always be spring/summer on western slope, winters in Denver.
 - There are other places like Pueblo, Colorado Springs where more members would attend.
 - Saber como entidad que significa ser autosuficiente en este aspecto.
 Knowing as an entity what it means to be self-sufficient in this regard.
 - We would be independent and supporting ourselves Tradition 7.
 - We could shorten the assembly length. (Friday could be a zoom meeting for new GRs), Saturday – Assembly, we could have food catered in wherever we are., Sunday – nothing.
 - Also, only have 2 assemblies, not 3.

- Autonomy as to fully self-supporting our fellowship.

- Possible less dilution of Al-Anon energies in one space potential triggers for some members being around members of AA.

- 4. What do you see as the disadvantages of Al-Anon holding Assemblies independently?
 - Cost.
 - Planning.
 - Less in the way of shared resources and traditional activities of shared speakers.
 - Change the dynamics to a degree.
 - Missing being with AA, it just feels right.
 - Probably less incentive for vendor to discount cost as numbers attending would probably most likely much decreased.
 - Financial.
 - Hospitality room could be an issue.
 - Couples/family members not being able to attend together.
 - ? Higher costs less bargaining power, lower number of participants.
 - Less of fellowship and interaction with AA.
 - Greater individual expense (possibly).
 - Getting enough volunteers.
 - More costly to Al-Anon financially.
 - More service and volunteers needed in planning.
 - Loss of help from AA.
 - Loss of diversity and cooperation between AA and Al-Anon.
 - More work.
 - AA/Al-Anon couples might not like it and quit service.
 - Cost cost is always the barrier. But as our programs are not for profit, couldn't we ask for discount rates?
 - It may be more expensive, leading to fewer GRs attending more may attend by zoom.
 - Cost of independent assembly.
 - Organization/infrastructure/connections needed to get comparable pricing/services, dates.
 - Recommendation: Can we track Al-Anon separate from AA participants at summer and winter assembly to get some date? # of rooms, # of tickets, Donations (amount).
 - The responsibility of guaranteeing we meet hotel rooms/meals. It could be a bust or a great change.

- Decreased opportunities for fellowship.
- Some people have husbands/wives on the AA side and it make planning easier if they both need to to.
- I have friends on the AA side and enjoy seeing them.
- Would we be able to afford on our own?
- Would discounts be reduced if we were a smaller group?
- What volunteer gaps would there be without AA?
- We shall "see" I guess. Hard to see at this point.
- I don't believe that it would be a lot more responsibility and work on Al-Anon's part.
- Are we up for the challenge?
- Loss of Al-Anon members who attend because their spouse attends AA.
- Create conflict within families with calendar issues.
- Increases WSC [AWSC] workload or makes it necessary to have members planning assemblies (venue).
- The power of many adds to our larger understanding.
- Cost.
- Loss of cooperation/interaction.
- Extra service work.
- Could an Al-Anon assembly be more efficient if we limited to one day, three time a year. These weekends are looong
- Based on what I know, have seen, I'm in favor of splitting. "Cooperation, not affiliation."
- There is cost advantage to holding assemblies together.
- Fewer people available to run assembly.
- More expensive?
- No AA speaker and extra activities like ice cream social.
- Possibly more expensive.
- Less fellowship opportunity and no joint speaker meeting (possible to solve by inviting a speaker for one night.)
- It might require even more cooperation among the Districts than already exists.
- No opportunity to participate with AA events open AA meetings, speakers, meals together, etc.

- Can Al-Anon afford it financially since we have markedly fewer members?
- I personally enjoy listing to and asking questions of certain AA's I've talked to during assemblies. It's informative for me and they ask questions about Al-Anon service, etc.
- Some people have spouses with family members in the other group, can attend at the same place and time, even if different rooms.
- Cost concerns.
- Less resources sharing/overall cooperation.
- Costs will go up for in person costs.
- Don't want to be that ingrown.

 assemblies would be far more that what the cost for Al-Anon is now.
