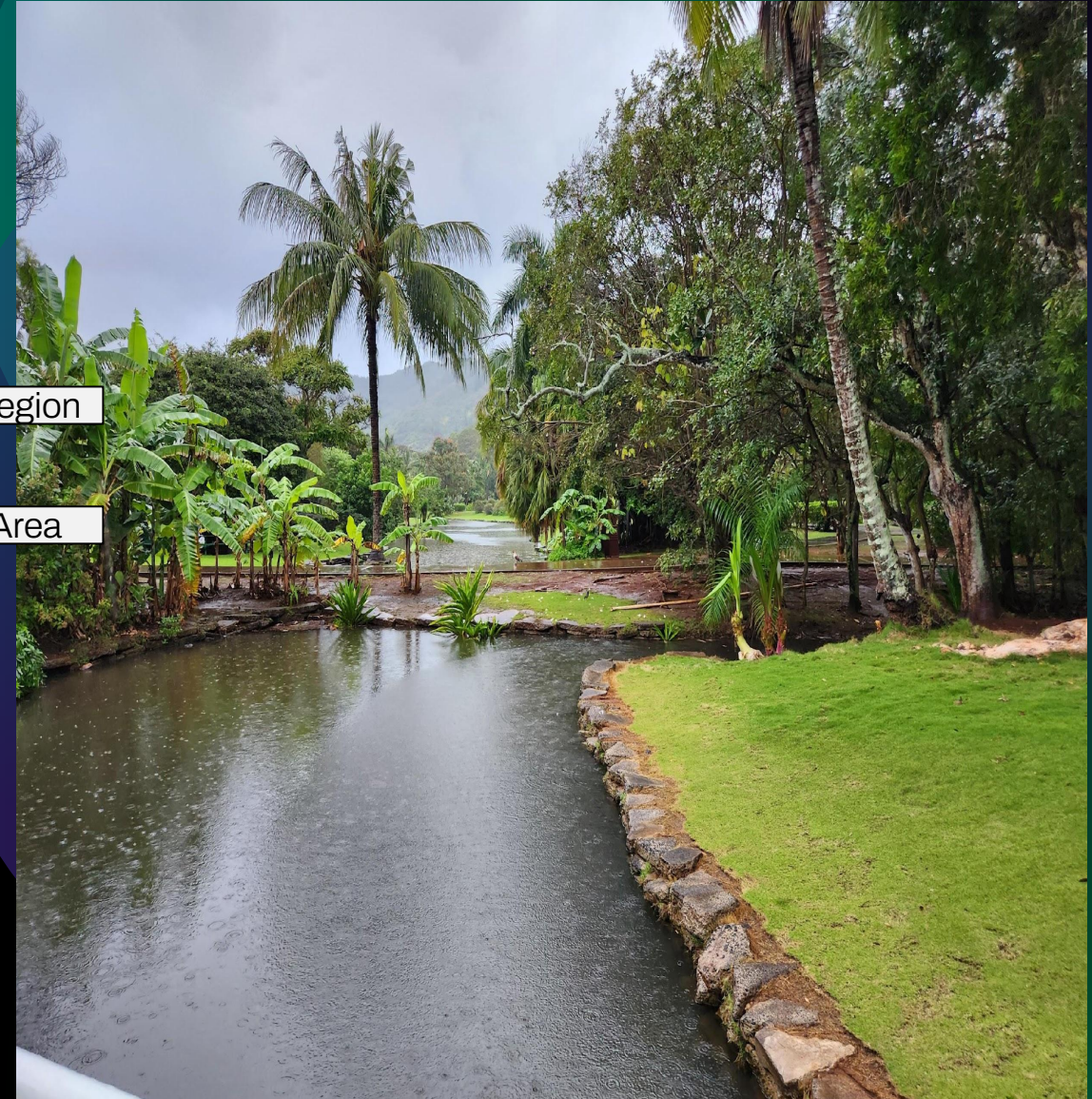

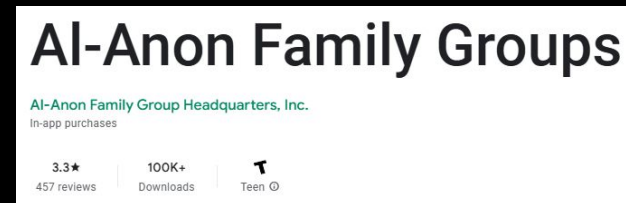

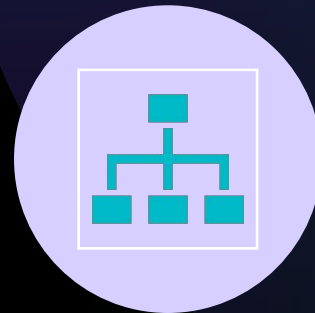

MAIN TAKEAWAYS:

- In 2024 only 62% of Groups contributed to the WSO, with an average of \$203.
- Will have 2025 numbers after WSC 2026, but it is estimated that the current cost for WSO to support each group is ~\$350 for a year.
- Only Al-Anon members can make Bequests, you must make WSO aware before you pass, and they can be for any amount.
